GUIDELINES FOR THE COMPLETION OF THIS FORM

1. In any area or question that does not apply to the individual club, please write "N/A" in the space provided. Review the award submission that the individuals listed on this application and obtain the proper sign-off of certification. **Without a proper sign-off (detailed above), the entry will be disqualified.**
2. **PART ONE** of this award consists of rubric-style points-based questions evaluating your work. You will answer questions and write the according point totals in the spaces provided. You should total the number of points for each section and enter the overall total for Part One of the report. Take note that Part One ALSO includes the very last page of this form, where you will need to verify your number of completed service hours.
 - a. Write each answer in the blank space directly to the right of each question. Possible answers include filling in a number of service hours or members, a percentage of some kind, or a YES/NO. For any Y/N questions, feel free to indicate your answer however you like. One possible method would be to **BOLD** either the Y or N.
 - b. Score these answers according to the instructions directly to the right of your answer, and write your point totals in the blank column directly to the right of the scoring instructions, being careful to pay attention to point maximums for each question.
3. **PART TWO** of this award consists of acquiring a letter of recommendation that adheres to the rules on the page, and your completion of three of four short essay-based questions that must be answered in the format below. Part Two **should not** be scored by you. The scoring section in Part Two is reserved for the judges' use and any unauthorized markings **will lead to disqualification** of the award.
 - a. Your report must be **TYPED, DOUBLE-SPACED, TIMES NEW ROMAN, FONT SIZE 12**. To keep things clean, begin each new section of the report on a new page, with the title of the section at the top of the page.
 - b. Part Two of this award consists of essay-based questions. **(Points will be subtracted if the response exceeds the number of pages indicated. Five points will be subtracted for each additional page.)**
 - c. Responses to each question are limited to **250 words**.
 - d. Each essay answer should be titled with the question as the first line by itself.

RULES GOVERNING REPORTING

1. The report should include activities undertaken during the period of February 21, 2019 to February 28, 2020 (last District Convention to current District Convention).
2. Part Two of the report must be typed. (See details above for length of responses. Points will be deducted if the response exceeds the number of pages indicated.)
3. Repetitious reporting of activities, fancy bindings, pictures, etc. will not be taken into consideration.

**Total service hours for each activity shall be reported by area: planning, travel, actual project time, and follow-up. A service hour is sixty (60) minutes of work performed by a member of a CKI club on a service project approved by the club or club board of officers.

Decisions of the judges are final, and no changes, alterations, or re-calculations will take place after the results have been certified by the contest committee members, the chairman of the contest committee, and the Circle K International Board Member of the contest.

- a. The letter should be no more than two double-spaced pages in length in 12 point font and signed by the writer. Be sure the following criteria are included:
 - i. Leadership and initiative in uniting the club.
 - ii. Organization and ability to administrate.
 - iii. Contribution to the club in relation to character and attitude.
 - iv. Describe how the president interacted and worked with club members, the club's executive board members, the club's committee chairs (if applicable), Kiwanians, and faculty advisor.
 - v. Growth and achievement of the club during the year.
 - vi. Overall participation in the club's activities.

B. Three out of four short answer essays of no longer than 250 words must be submitted with this application, **written by the nominee**. Please follow the format instructions below:

- a. How did you personally promote Circle K education to your club and your campus/community?
- b. How have you personally promoted fellowship, club spirit, and motivation to club members?
- c. How have you personally promoted district events, international events, and joint club activities with Kiwanis Family?
- d. How has being the President of your club helped you grow as a leader over the course of the year?

*Each essay answer should be titled with the question as the first line by itself. Please type in double spaced, Times New Roman font, size 12. Each essay answer should be no longer than **250 words**.*
